## Memorandum of Understanding (MoU) between The Territorial Community of Voznesensk city (Ukraine) and

# Ikast-Brande Municipality (Denmark) on the establishment of a solidarity partnership

The Territorial Community of Voznesensk city and the Ikast-Brande Municipality are united in their aim to develop ties between their people in the interest of peaceful coexistence and in the spirit of international cooperation, tolerance and mutual understanding.

#### 1. Areas of cooperation

- 1.1 The Territorial Community of Voznesensk city and Ikast-Brande Municipality hereby agree on a solidarity partnership, which forms the foundation for the development of a long-term friendship between the two communities.
- 1.2 Within the limits of their responsibilities and possibilities, the communities will be strengthening relations and cooperation in areas of mutual benefit and prosperity.
- 1.3 These objectives will be achieved through many forms of cooperation, such as exchange of know-how, partnerships, commerce between business enterprises and reciprocal visits by delegations from the cities, organizations, associations etc.
- 1.4 Areas of cooperation under this MoU include, but is not limited to, the following:
  - · citizenship and humanity,
  - · economic development, trade, commerce and industry
  - · green transition including urban management,
  - environment and sustainability,
  - science, technology, and education,
  - culture, health and sports,
  - youth policy

1.5 The specific activities of cooperation will be agreed upon by the administrations of The Territorial Community of Voznesensk city and Ikast-Brande Municipality.

### 2. Final Provision

- 2.1 The parties consider this Memorandum of Understanding between The Territorial Community of Voznesensk city (Ukraine) and Ikast-Brande Municipality (Denmark) on the establishment of a solidarity partnership as a declaration of intent that does not result in legal or financial consequences or obligations for either of them.
- 2.2 This Memorandum of Understanding between The Territorial Community of Voznesensk city (Ukraine) and Ikast-Brande Municipality (Denmark) on mutual understanding and solidary partnership enters into force on the day of its signing and is valid for five years. The Memorandum may be renewed for the same term and under the same conditions upon agreement of the parties concluded before the expiration of the Memorandum.
- 2.3 This Memorandum may be terminated by either party by written notice of termination to the other party.
- 2.4 This Memorandum on mutual understanding and solidary partnership between The Territorial Community of Voznesensk city (Ukraine) and Ikast-Brande Municipality (Denmark) is available in three copies in Ukrainian, Danish and English. Both cities will receive one copy in each language. All versions are considered equally authentic and valid. In the last instance, the English version shall prevail.
